### HOMOLOGATION SERVICE

Applus IDIADA is one of the most active European Technical Services in the field of braking systems and brake components homologation.

All replacement brake drums and discs intended for use in friction brakes have to be separated in 4 groups, depending on geometric, chemical and mechanical properties. The number of tests necessary for compliance with the Regulation depends on which of the 4 categories the replacement disc or drum belongs.
