

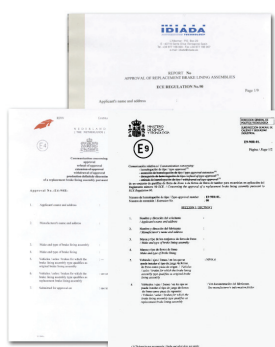


Motorcycle Homologation

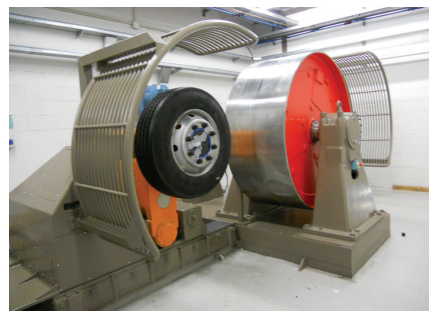
PROFESSIONAL TEAM
